Difference between Tax Return and Audited Financial Statements

Subsequent to the finalization of the audited financial statements, management determined that its allocation of Officer wages, for the purpose of the audited financial statements, had been understated with respect to program and overstated for administrative expenses. As a result, management elected to report the adjusted percentages for the tax return purposes. The difference resulted in a reclassification from administrative expense to program in a total amount of \$23,913. Management and the Organization's auditors determined that the difference was immaterial to the financial statements taken as a whole.
